## DEADLINE TODAY FOR PROVISIONAL TAXPAYERS 2014 INCOME TAX RETURNS DUE 30 JANUARY 2015

Deadlines set by SARS are some of the most important for investors to take note of. This alert by your financial planning and advice team at Brenthurst Wealth is a reminder that one of the key deadlines are upon us.

Contact your tax practitioner or SARS immediately for assistance in the event that your tax returns have not been finalised to avoid penalties. Kindly note that payments are also due today for those provisional taxpayers who submitted their returns in November 2014.

*"All individual taxpayers who receive income other than salary income may be required to register as a provisional taxpayer and submit returns twice a year",* says Gavin Butchart, Brenthurst Wealth tax expert.

*"This can be income earned either from contractual work, business trade activities, property rental or interest earned on investments",* he added.
